#### Program Policies

##### Participation

**ADVENTURE 360** reserves the right to accept, decline to accept, or remove any participant from this program if it is deemed that the actions of the participant endanger other program participants or creates undue hardships to the program as a whole. If a participant is removed from a program, they will not be refunded the unused portion of their fees and, upon removal, all rooms fees, meals, transportation, airfare or other costs will be the sole responsibility of the removed participant.

##### Health

You must be in good physical and mental health. Any physical condition requiring special attention, diet, or treatment must be reported on the registration forms. Activities will not be overly rigorous but participants should be ready to be active. **ADVENTURE 360** is able and willing to work with individuals of most abilities and backgrounds.

##### Eligibility

This program is open for adults, adults with youth 8 and older and youth at least 16 years.

##### Fossil Collection

**Paleo X** is a unique *paleontological* experience designed to provide participants with a broad view of the fields of paleontology, geology and the world of the dinosaurs. Our experiences are located on federal- and state-owned land where specific permits are required. Fossils collected are the property of all U.S. citizens and therefore, cannot be owned by private individuals. Collection of fossils without federal or state permits could result in federal and state investigation including legal prosecution.

During **Paleo X** programs, all collected materials are provided to a federal repository who then may loan material to **ADVENTURE 360** for educational purposes. Any participants

keeping any fossils during this Paleo X program will be dismissed from the program with no refund of fees and their actions will be reported to the appropriate state or federal authorities.

## Collection of Artifacts

**Paleo X** is a unique paleontological experience designed to provide participants with a broad view of the fields of paleontology geology and the world of the dinosaurs. Our experiences are located on federal- and state-owned land where specific permits are required. Collection of archaeological artifacts without the required permits could result in federal and state investigation including legal prosecution. Therefore, it is the policy of **ADVENTURE 360** that there will be no collection of Native American artifacts or historical artifacts during its Paleo X program. These artifacts include but are not limited to Native American arrowheads, spear points, campsites and historical camp sites. Any participants collecting artifacts during the Paleo X program will be required to return artifacts to **ADVENTURE 360** staff and their actions will be reported to the appropriate state or federal authorities. **ADVENTURE 360** reserves the right to dismiss any participant from the program with no refund of fees for the collection of archaeological artifacts.

## Firearms

**ADVENTURE 360** provides a safe environment for its participants. Firearms of any kind, including those legally permitted, are strictly prohibited on all **ADVENTURE 360** programs. Any person participating in any **ADVENTURE 360** program possessing, obtaining or assisting in the acquisition of any firearms, for any reason, will be dismissed from the program immediately. Upon removal from the program, no fees will be refunded. All rooming fees, meals, transportation, airfare or other costs will be the sole responsibility of the removed participant.

Accordingly, I agree to assume all of the risks and responsibilities in any way associated with my and members of my group's participation in this program and agree that **ADVENTURE 360** is not responsible for the acts or omissions of any person or provider which is not under the control of **ADVENTURE 360** including, but not limited to, providers of transportation and accommodations. In consideration of the services, facilities and other assistance provided to me by **ADVENTURE 360** in connection with this program, I hereby release **ADVENTURE 360** from any and all liability, claims and actions that may arise from any injury or harm (including, but not limited to, fatal injury) to me, or damage to my personal property occurring in connection with this program.
